Eligible recipients must have an income at or below 80% of the area median income and lack adequate insurance coverage or financial resources to access necessary medical care. This program helps ensure that financial constraints do not prevent individuals from obtaining critical medical treatment.

Coaching and Financial Counseling - Collective Kindness provides coaching and financial counseling to families seeking guidance in managing their financial challenges. This service is open to all families in need of financial support, with priority given to those whose household income is at or below 80% of the area median income. Participants must demonstrate a commitment to actively engage in a structured financial treatment plan designed to help them achieve stability.

Mortgage Assistance - Collective Kindness supports homeowners at risk of foreclosure due to temporary financial setbacks. To qualify, applicants must have an income at or below 80% of the area median income and demonstrate a viable plan for resuming regular mortgage payments within 3-6 months. The program is designed to provide short-term assistance to prevent foreclosure and help families maintain stable housing.

For individuals facing medical hardships that impact their financial stability, the organization helps bridge gaps in coverage when adequate insurance or financial resources are unavailable. Special consideration is given to families with children and to unique circumstances related to Jewish life, including educational and religious milestones. Collective Kindness ensures that assistance is granted based on an objective determination of need and maintains thorough documentation of eligibility criteria and selection processes.
