Assistance may include emergency support for essential living expenses such as housing, utilities, medical costs, food, or other critical needs. Eligibility is based on demonstrated financial need, and assistance is intended to stabilize households during periods of crisis while encouraging participation in supportive services where appropriate. The program helps prevent eviction, utility shutoff, medical disruption, and other destabilizing events.

4b (Code:) (Expenses \$ 176,181 including grants of \$) (Revenue \$) COACHING & COUNSELING - The organization provides individualized coaching and counseling services to individuals and families experiencing financial stress or personal hardship. Services include structured goal-setting, budgeting guidance, crisis planning, and accountability support designed to promote long-term financial stability and personal well-being. Participants are typically low-to moderate-income individuals facing financial instability or transitional life circumstances. The program emphasizes education, behavior change, and sustainable financial practices to help participants achieve greater independence and stability.

4c (Code:) (Expenses \$ 74,957 including grants of \$) (Revenue \$) FINANCIAL COUNSELING - The organization offers direct financial counseling services to individuals and families with limited income or experiencing economic hardship. Services include budget development, debt management planning, credit review, savings strategies, and financial literacy education. Counseling is provided through one-on-one sessions and structured financial action plans. The program is designed to improve financial capability, prevent crisis situations, and support long-term economic self-sufficiency.

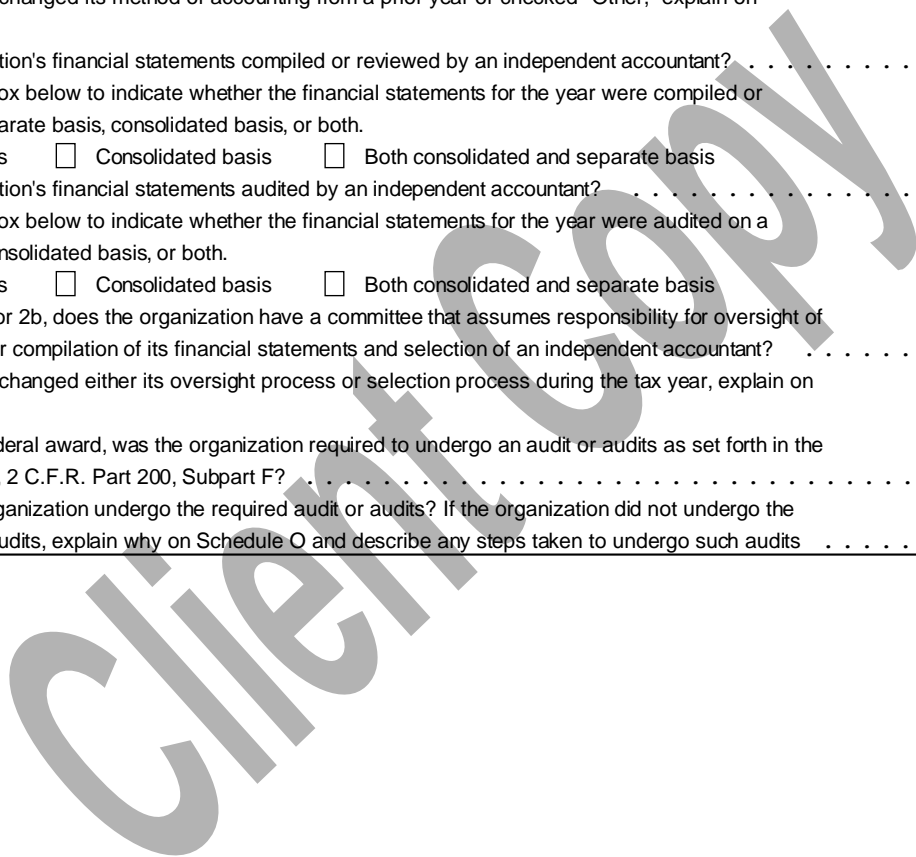
